#### Introduction

SIB respects the right to privacy and confidentiality of our users Personal Information. This Policy complies with the principles contained in the Consumer Protection Act 61 of 2008 relating to direct marketing, in the Electronic Communications and Transaction Act 25 of 2002 ("ECT"), for electronically, collecting Personal Information and the right to notify data subjects how we handle Personal Information given to SIB, as per the Protection of Personal Information Act 4 of 2013 ("POPI").

This Policy describes how sib.co.za collects, uses, and discloses your Personal Information when you visit or make a purchase from our Site.

Through your interaction with us, SIB collects Personal Information which, is described by POPI, as information relating to an identifiable, living, natural person, and where it is applicable, an identifiable, existing juristic person. Personal Information may include, but is not limited to, your name, physical address, telephone number and e-mail address.

You may not access our services on our Site if you are younger than 18 years old or do not have legal capacity to conclude legally binding contracts.

## **Collecting Personal Information**

When you visit sib.co.za, we collect certain information about your device, your interaction with the Site, and the information necessary to process your purchases. We may also collect additional information if you contact us for customer support. In this Policy, we refer to any information about an identifiable individual (including the information below) as "Personal Information". See the list below for more information about what Personal Information we collect and why.

#### • Device information

- Purpose of collection: to load the Site accurately for you, and to perform analytics on Site usage to optimize our Site.
- Source of collection: Collected automatically when you access our Site using cookies, log files, web beacons, tags, or pixels
- o **Disclosure for a business purpose:** shared with our processor Shopify
- Personal Information collected: version of web browser, IP address, time zone, cookie information, what sites or products you view, search terms, and how you interact with the Site

#### Order information

- Purpose of collection: to provide products or services to you to fulfil our contract, process your payment information, arrange for shipping, provide you with invoices and/or order confirmations, communicate with you, screen our orders for potential risk or fraud, and when in line with the preferences you have shared with us, provide you with information or advertising relating to our products or services.
- o **Source of collection:** collected from you.
- o **Disclosure for a business purpose:** shared with our processor Shopify
- Personal Information collected: name, billing address, shipping address, payment information (including credit card numbers, email address, and phone number.

#### • Customer support information

- o **Purpose of collection:** to provide customer support.
- o **Source of collection:** collected from you

We may also process, transfer and disclose your Personal Information (which will normally be retained on a database) for the purposes of:

- o offering products for sale and keeping you up to date on new products, services, and offers;
- Auditing usage of our Site;
- o Storing the terms and conditions which bind you; and
- o Any other purpose which is reasonably necessary in the circumstances.

We ask that you not send us, and you not share any special personal information (e.g., biometric information, information related to racial or ethnic origin, political opinions, religion or other beliefs, health, criminal background or trade union membership).

## **Processing your Personal Information**

By providing your Personal Information to SIB you acknowledge that it has been collected directly from you and consent to its processing by SIB.

Where you submit Personal Information (such as name, e-mail address and, telephone number) via the Site (i.e. through completing the online form) the following principles are observed in the processing of that information: -

- SIB will only collect Personal Information for a purpose consistent with the
  purpose for which it is required. The specific purpose for which information is
  collected will be apparent from the context in which it is requested and as
  outlined in terms of this Policy.
- SIB will only process Personal Information in a manner that is adequate, relevant and not excessive in the context of the purpose for which it is processed.
- Personal Information will only be processed for a purpose compatible with that
  for which it was collected, unless you have agreed to an alternative purpose in
  writing or SIB is permitted in terms of national legislation of general application
  dealing primarily with the protection of Personal Information.
- SIB will retain your Personal Information for as long; as needed to provide you
  with our services; as needed for the purposes outlined in this Policy or at the time
  of collection; as necessary to comply with our legal obligations; or to the extent
  permitted by law.
- SIB will destroy or delete any Personal Information that is no longer needed by SIB for the purpose it was initially collected, or subsequently processed.
- We may need to transfer your Personal Information to another country for processing or storage. We will ensure that anyone to whom we pass your Personal Information agrees to treat your information with the same level of protection as we are obliged to. You hereby consent to the transborder transfer of your Personal Information in the event that the need arises.

## **Sharing Personal Information**

We share your Personal Information with service providers to help us provide our services and fulfil our contracts with you, as described above. For example:
